**Meal Kit Offer—Official Rules**

1. **Offer Period:** The “Offer Period” is from 2:00:01 am Eastern Time (ET), January 8, 2018 (“Offer-Start”) to 11:59:59 pm ET March 31, 2018 (Offer-End”).
2. **Sponsor.** The Promotion sponsor is Aramark Educational Services, LLC, 1101 Market Street, Philadelphia, PA 19107 (the “Sponsor”).
3. **Gift.** A total of 300 boxed meal kits (each individually a “Gift”) are available for the Offer.
4. **Eligibility.** The Offer is open only to legal residents of Virginia who are lawful permanent residents or are lawfully present in the U.S. pursuant to a valid non-immigrant visa, and (i) who are 18 years of age or older at the time of entry and (ii) who are registered students or employees of James Madison University. 5. **How to Enter.** To receive the Gift, you (“Purchaser”) must do the following: purchase a voluntary meal plan during the January voluntary meal plan selling period by the peer to peer team (“Qualifying Purchase”). If the Purchaser chooses to participate in the Offer, then the first 150 Purchasers must provide their name and e-mail address, and they will be contacted by a third-party meal kit provider that will provide instructions on how to redeem their Gift free-of-charge. The third-party meal kit provider will ship the Gift to the address designated by the Purchaser. The third-party meal kit provider will provide the Gift during a redemption period that runs from February 1, 2018 through March 31, 2018. Offer is valid while supplies last or until the end of the Offer Period, whichever occurs first. All redemption requests must occur by March 31, 2018 at 11:59:59 pm ET. Only two (2) redemption per person during the offer period.
6. Gifts are not redeemable for cash or exchangeable for any other item. Gifts are non-transferable and may not be given, bartered or sold. There are no cash or Gift substitutes. 7. By participating in the Offer, participant agrees to be bound by these official terms and conditions. Sponsor will conduct the Offer substantially as described in these terms and

conditions. However, Sponsor shall retain the right to abbreviate, extend, modify, or cancel the Offer without any further obligation due to events beyond its control.

8. Sponsor reserves the right to invalidate Gifts if it determines, in its sole and absolute discretion, that such Gifts were improperly obtained by participant for any reason whatsoever, including without limitation by fraud. Any failure to abide by the official terms and conditions, any conduct detrimental to Sponsor, or any misrepresentation or fraudulent activities in connection with this Offer may result, in addition to any rights or remedies available to Sponsor in law or equity, in forfeiture of any or all Gifts accrued to the relevant date and any other benefits earned in connection therewith, in the sole and absolute discretion of Sponsor.

As a condition of participating in this Offer, participant: (1) agrees that all issues and questions concerning the construction, validity, interpretation and enforceability of these official terms and conditions, participant's rights and obligations, or the rights and obligations of Sponsor in connection with the Offer, shall be governed by, and construed in accordance with, the laws of State of Pennsylvania, without giving effect to any choice of law or conflict of law rules; (2) consents to the jurisdiction and venue of the federal, state and local courts for Philadelphia, Pennsylvania; (3) agrees that any and all claims, judgments and rewards shall be limited to actual out-of-pocket costs incurred, including costs associated with participating in this Offer, but in no event attorneys' fees; (4) agrees that under no circumstances will participant be permitted to seek recovery for, and participant hereby waives all rights to claim, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and waives any and all rights to have damages multiplied or otherwise increased; and (5) agrees to be bound by these official terms and conditions and the decisions of Sponsor, which are final and binding, without right of appeal, with respect to all aspects of the Offer, including without limitation, eligibility of participants and validity of Gifts.

Entrant(s) acknowledges and understands that any information provided will be used for administering the Offer and in accordance with Aramark privacy policies. The sponsor(s), promotional partners and administrator are herein collectively referred to as the Offer Entities.

In the event of any conflict with any Offer details contained in these official terms and conditions details contained in Offer materials (including but not limited to point of sale, television, and print advertising, promotional packaging, and other Offer media), the details of the Offer as set forth in these official terms and conditions shall prevail.

These official terms and conditions constitute the entire agreement between Offer participants and Sponsor pertaining to the subject matter hereof and supersedes all prior or other arrangements, understandings, negotiations and discussions, whether oral or written. No waiver of any of the provisions of these official terms and conditions shall be deemed or shall constitute a waiver of any other provisions hereof (whether or not similar), nor shall waiver constitute a continuing waiver unless otherwise expressly provided. If any provision of these official terms and conditions is found to be invalid or unenforceable by a court of competent jurisdiction, such provision shall be severed from the remainder of these official terms and conditions, which will otherwise remain in full force and effect.
